Streets

Phil visited twice this month to relook at all the streets to complete his proposed plan for this year.

Platte County gave us a list of supplies we could use for the streets. Nicole asked if going under the Platte County purchasing does that mean we will get the same cost they receive to do the streets? Audrey advised we already get a discount for being a municipality that going though Platte County will give us a break on stop sighs or road signs that we need. Nicole asked that if we were to put in a culvert at the trailer park could we bill the owner. The attorney advised we would need to send out a letter giving him an opportunity to fix himself and if not done in the amount of time giving then yes we could install the culvert and then file a lawsuit against him. The mayor advised the clerk to give Dan the information so a letter can be sent out.

Water

1 possible water leak. Continue work on the USDA grant for the water. 34,167 DAU down from 53,672 in 2020.

Sewer

Benson has completed the work on the Levee. 4 terraces has been repaired and grass seed has been put down on the Levee.

Park grant work has begun. We are mowing and have updated the grass pad account.

7. <u>Citizen input</u>

Also one of our dates are July 3rd and did not know if they city was planning to do anything for the 4th of July? The board advised no they were good to use the park on that day.

Nancy Montgomery- We mow the memorial and are having problems with a vicious dog. Mayor Harmer advised we do have that on the agenda to discuss.

Nancy started she sees where the minutes are on the webpage but would like to see the agenda on there. The clerk advised her that she is in the process now of getting the agenda on the web page will be up and going within the next few months. Nancy also stated she would like the bills posted on there also. The clerk advised that would be a board decision to make but these records are open and anyone can come down to request a copy. We have several accounts with several bills being paid out of them and would take a lot of space to scan into the server. Mayor Harmer stated we can discuss this in the upcoming working meeting. Nancy also asked that since we have a ordinance to put up your trashcans after trash pickup why has this not been enforced? Mayor Harmer advised we will look into the ordinance and discuss at the work meeting. Nancy stated there is a rail missing from the skate park and now there is bolds sticking up and is going to hurt someone. Audrey stated she will get that taken care off.

Joel Dudley-I have noticed down at the playground area there are not functioning bathrooms and the graffiti that is on it. Is there a way to have volunteers come and help with getting that cleaned up and back open? Audrey advised she did have some volunteers from the senior class start on cleaning it up but did not come back to finish as far as the bathrooms there is a water leak and it has now been located and they are in the process of starting the repairs. Mr. Dudley advised he is a licensed plumber and would more than happy to volunteer to do the work to get the bathrooms back up and running.

Joel also asked what could be done about the track being covered in mud. Audrey advised the track was build in a flood plain so every time the creek overflows it goes right through the track area. We do not have the funds to raise the track nor have the correct equipment to clean the track off after a flood. Mayor Harmer advised he will look for park grants to see if we could get help with raising the track up.

Mayor advised there are trashcans all over the park areas and would not need to add any receptacles to discharge waste. Audrey will put white tape over the signs that say no dogs allowed until we can get new signs ordered.

Mayor Harmer advised the board that a park grant has been approved for the trashcans and BBQ grills but the flowers had not been approved. Audrey went over the cost for the flowers and that we will be 100% reimbursed for them.
