Sent out certified abatement letter to trailer park for the trash, weeds, and upkept mobile homes. Certified letter to the villas regarding the baby wipes in the pump again. Sewer- Sewer samples were taking. Alex has been sampling the lagoon two times a week. Baby wipes gummed up floats at villa lift station, invoice sent certified mail. Villas lift station is running on one pump now. DNR inspection was done on the lagoon this month.

Water- Water samples were taking, Water meter read for October. One water main break. We flushed the fire hydrants this month. Had a plumber snap off the meter riser on our side.

Parks- Winterized the bathroom.

Public Works- 10 dig rites completed, Had the cylinders rebuilt on the snowplow. Went to the macto conference. Sealed city hall parking lot.

Mayor Harmer asked about the fire hydrant at B and Main. Travis advised the water to the hydrant is shut off at this time due to discovering the other main during the water leak. The fire department is aware that the hydrant is out of order until we can fix the issue to it.

Gary: A gentlemen that lives outside of Edgerton asked him if he had to get a permit from the City on his ATV. The clerk advised if he is driving it on City Street then yes, he has to have a permit.

Water rates: The clerk provided the board with the ytd number for this year and the final numbers from last year on the cost of maintaining the water and billing the customers. Travis advised the board we needed to stay above the curb. The mayor postponed the matter until the next working meeting December 14th.

Boot allowance: Travis asked to board if he can get a boot allowance. Aldermen Dudley asked if his dress code required a class 1 or class 2 garments? Travis advised the dress code is just steel toed boots and skin covered. Mayor Harmer postponed the matter until the December 14th meeting.

Work orders: The clerk went over the process of work orders. Any member of the board or any resident of Edgerton can come and fill out a work order. This provides the paper trail needed to get issues completed.

Text alerts: The clerk advised the board during the last water break several people approached me wanting to have alerts sent out in regards to issues like this. The clerk advised the board the water software we use does have that capability and the cost to use it would be 320.00 a year. The board help a brief discussion and the residence that were at the meeting agreed that Facebook and if we have an boil advisory the board outside works just fine.

Company to scope out possible crushed sewer main: Travis advised the board that there is a section of the road that is caving in due to what is believed to be a crushed sewer main and would like to get a company out the scope and jet the line.
