Sewer- Sewer samples were taken. Alex has been sampling the lagoon two times a week. Work on the lagoon ponds is finished. Sod was put on the banks. We had the villa lift station pumped out along with the main lift station. We have a bad check valve on the main lift station.

Water- Water samples were taking. Water meters were read. We now have 173 electric meters in the ground. One water main and service like break.

Option two is to hire county which when last investigated around 6 years ago they wanted \$35,000.00 for only 15 hours a month. Mayor Harmer advised we will let county know that we no longer have a police department, and they will come into town once a day. The board agreed at this time to let the police department go.

Levee: Travis asked the board that there are trees at the levee that needs to be removed he stated Logan can take out the trees for \$4,999.00.
