4. Reports

City Clerk- Sent out 24 past due shut off notices. 0 on the payment plan. 3 residences shut off. Spring clean up went very well. Thanks to everyone who took the time out to help. We collected \$22.00 for the tires and \$234.60 for the scrap. Travis and I attended the MML training in Kearney. Had an 811 Training (formally Mo one call) at city hall.

Sewer- Sewer samples were taking. Alex has been sampling the lagoon two times a week. Work has been started on the lagoon. Irrigation is up and running. Lagoon mowed.

Water- Water samples were taken. Water meter were read. Had a meeting in Plattsburg.

Parks- Bathrooms are open and ready at city park. Lots of mowing.

Streets- Filled potholes with cold patch. The road behind Nash's is completed.

Public Works- 28 dig rights for the month. We had the city cleanup. We sold the scrap metal. Mower maintenance is done every Friday.

Police- No report provided.

Emergency management- Siren went off.

Joel Dudley- Where are we with the dangerous buildings on main streets? Amy advised that 2 letters were sent one of the owners has responded with a plan of action and that is to tear it down by the end of the year. The other building owner did not respond, and I have left that information with the chief of police.

At the corner of Hines, the sidewalk is falling. Travis will look at it.

In regards of the sidewalk ordinance, it states that if 10 residents sign a petition to enforce a resident to put in a sidewalk what would happen on the city's side. Travis stated he was also told if we turn over the responsibility of the sidewalk, we also give them the easement. The mayor asked Amy to contact the attorney and find out what we can do about in regard to the sidewalks.

Ronna- When we first opened our business our water bill was over \$500.00 a month then Travis put in a new meter, and it is a lot lower. I just wanted to let you know so as not to base the budget off the old readings.

Nate- Went over the electrical in the park with the board he also stated he will need a trencher and a mini. The mayor advised Travis to get pricing to rent one for two months. Nate also stated he would need a purchasing order.

1st and 2nd reading of ordinance 18-042 amending chapter 510, section 510170 repairs of sidewalks were tabled due to new information that was discovered.

Truck- Travis advised the board that he needs a spending limit to know how much he can spend. Mayor Harmer asked Amy what the finances are, she advised that anything over \$10,000.00 would be pushing it. The board decided they would need to spend more than that to get a good working truck that would last. The board advised Travis to look into financing a truck for around \$20,000.00 to \$22,000.00.

Lids and Collars- Travis advised the board he needs to purchase more lids and collars to finish out installing the rest of the radio read meters. The cost would be \$2,507.41 and would like to take it out of the ARPA money.

Motion to purchase lids and collars out of the ARPA funds to not exceed \$3,000.00.
