Parks-Been working on the park grant.

Aldermen Bosch asked Travis what the park grant was. Travis started to get mulch in the park and replace the sign at the memorial. Aldermen Bosch asked when this discussion came up? Travis stated back in October.

Aldermen Kidwell asked Travis if the post office get ahold of you? Travis stated the mailboxes have not been moved and he has not heard back from them but will follow up.

Streets- All road work has been completed for the year. New handle on the truck.

Public Works- 12 Mo one calls completed.

Police-13 calls taken for the month.

Emergency management- Siren did go off.

### 7. <u>New Business</u>

### Amend section 505.070.

Amy advised the board that the abatement letter refers to this section of the ordinance that states IBTS is the building commissioner and would like that changed to the abatement officer. Aldermen Dudley stated he does not believe it could be changed to the abatement officer due to not being an inspector. Mayor Harmer asked Amy to reach out to the city attorney and have her look over the ordinance and see how we should proceed.

### Amend section 705.300.

Travis is having an issue with a gentleman who would like the city to pay for his connection into the main and would like to have the water regulations changed to read that it is the responsibility of the resident to hook up to the water main like the sewer regulations state. Aldermen Dudley stated it is already written in the ordinance that they would have to pay the city to do the connections. And that it also states that the board must approve the permit. Travis stated he would tell the gentleman that he would have to come to a board meeting.

At this time Mayor Harmer advised the board that this was to be his last year as the Mayor but there is a few things he is working with the board on and has submitted his paperwork to run again.
