Assisted Alex with the DNR questioner. 1 leak rate giving. 2 dangerous building letters sent out certified mail. Provided the bond company with all expenditures in 2023.

Sewer- Sewer samples were taken. Alex has been sampling the lagoon two times a week. We got the aerator installed at the main lift station. We put 4 new tires on the irrigation towers. Maintenance of the irrigation system.

Water samples were taken. Water meters were read. Two water main leaks fixed, both were east of town. We got 3 new water meters installed and only five left to go.

Parks-Mowing season has started.

Streets- Filled potholes. Gravel should be here next week.

Public Works- 16 dig rites for the month.

Police- Addressed a couple of buildings, one of which has been in contact with me, and I have giving him till July 3<sup>rd</sup>, 2024, to take care of the issue. Couple phone calls regarding chickens in city limits. I do have a few open cases 2 of them are violation of the order of protection and an open narcotic investigation. Been also following up on complaints through Facebook messenger on the police page. Attended training. Received a ptd machine from the state of Missouri. The reserve officer is halfway done with training. I will have another training coming up in June.

Vikki Kidwell- On the Edgerton webpage it says we are taking bids for disposal. Mayor Harmer stated he will have the IT guy remove the bid.
