4. Reports

City Admin- Sent out 29 past due letters. 1 on the payment plan. Shut 1 residence off. All paperwork is filled out and sent back to the county for the set taxes. 1 building permit was issued. Working with getting the water software switched over.

Sewer- Sewer samples were taken. Alex has been sampling the lagoon two times a week. Rented a generator to move our pivot back out of the field. I currently have the generator torn apart that runs our irrigation pivot. I'm trying to diagnose the problem. We got rid of about 100,000 gallons of wastewater from the lagoon. Discharge pump for the irrigation went down and will need a new clutch assembly.

Water samples were taken. Water meters were read. Had a service line break. Spent a lot of time working with the engineers on the water extension. Spoke with Shawn about pricing a new pressure pump for the main pit.

Parks-Lots of mowing. Hot water tank installed at the concession stand. Had to fix a broken water line in the bathroom. New wax ring for the bathroom at the park.

Streets- Filled in potholes. New stop sign on Aller to replace the stolen one.

Public Works- 11 dig rites on for the month. Mower maintains every Friday. Travis then went over our engineer report with the board that was provided by Scott Fleming. Mayor Harmer asked if Amy could reach out to the realtor and Graves to set up a meeting for the 25th at 5:00 pm. Mayor Harmer advised Travis the mulch would be delivered the week of the 21st. Travis let the board know that Plattsburg will be doing another chlorine burnout beginning Sunday and will last around 2-3 weeks the water will have a pool smell to it but will be safe to drink.

Work orders- 0 new work orders

Police- The police department has been asked to become a member of the Missouri Department of transportation correlation safety roadways. I have accepted the invitation and attended a meeting this morning. They will be providing us with signs that will say buckle up phone down. The City of Claycomo has donated a radio for the police car. Spoke with Platte Co and they will have a couple officers assist with Pioneer days. I heard that there were some complaints regarding a nuisance violation, when I get the complaint, a letter is sent out and they have 10 days to correct the situation if the violation is corrected and another complaint comes in down the road, they will then receive another letter which will give them 10 days again to correct the violation. If the violation is not corrected, then a citation will be given. Chief Rivers stated there is a difference in a nuisance violation and just bad housekeeping I cannot fault your neighbor for sloppiness.

Emergency management- Siren did go off.

Joel Dudley- At the last meeting we discussed changing a couple of ordinances. Amy advised that we have postponed that discussion until we can hire a city attorney to amend the ordinances that are in question.
