4. Reports for both January and February

City Admin- Sent out 78 past due letters. 0 on the payment plan. Shut 0 residences off. Candidate filling has been turned into Platte Co election board. Direct and overlapping papers have been submitted to Platte Co. Still working out the bugs in the billing software. The new water rate ordinance has been hung outside for the public to review. Collected and submitted all paperwork to receive the funds back for the police grant. Signed in the newly appointed Aldermen Alec Williams.

Sewer- Sewer samples were taken. Alex has been sampling the lagoon two times a week. We are back to running on two pumps in the main lift station. Villas lift station is down. We have been pumping it out once a day with the vac truck I do believe we have a plug line that has caused me not to have a day off since February 1st. I put a clean out on the villas sewer main and tried to jet the line ourselves we just did not have enough pressure to get through. H&H came out and could not get their Jetter around the 90-degree corner.

Water samples were taken. Water meters were read. Had two meters freeze and one broken.

Parks- Still working on the lights.

Streets- A lot of plowing and salting.

Public Works- 19 dig rites for the month. I have been getting the insurance company the information needed to get higher coverage on the water supplies.

Work orders- 0 new work orders. Mayor Harmer stated there is a good size pothole in front of the RV park. Travis said he will go put some gravel in the hole and once the temperature warms up, he will patch it.

Police- Attended a meeting with the local sheriff's departments and metropolitan chief of police where we all signed a agreement and understanding with the Missouri Western narcotic task force which they will share information with the federal government in regards to cases, they also agree to help with undercover operatives here. In the month of January and February we have had an increase in calls of service. A few cars stopped. Nuisance violation. Dangerous building letter sent out. I have made a mistake and did not

redact some information but going forward I will ensure that private information will be redacted. Monday we will finish our firearms training and will qualify.

Mayor Harmer advised Chief Rivers to get with Dan on the issue of the police reports.

Aldermen Joel Dudley asked Chief Rivers if letters have gone out to the house's over on Clark? Chief Rivers stated he has not had a complaint about any houses.
