#### **4. Reports**

City Admin- Sent out 27 past due letters. 1 on the payment plan. Shut 1 residences off. Updated the new check signer. ARPA final reporting is completed. Workman comp audit completed. Still providing info to the state on the reimbursement of the police grant. Bid for electrical has been posted and will expire on the 19<sup>th</sup> of May.

Sewer- Sewer samples were taken. Alex has been sampling the lagoon two times a week. Been working on the irrigation.

Water samples were taken. Water meters were read. The water tower was cleaned out. I have been going to water classes.

Parks- Lots of mowing. Got the electrical out for the bid.

Streets- Filled potholes.

Public Works- 11 dig rites for the month. We put in 300 feet of new field tiling. Had a new alternator and solenoid put on the backhoe. New alternator in the truck.

Work orders- 2 new work orders and have been completed.

Police- 2 car stops, 2 disturbance calls, 1 nuisance violation and 1 fraud report. The sheriff of Platte County called a meeting for all Platte County chiefs of police on April 22<sup>nd</sup>. The primary discussion was about the radio communication system we all share as well as our ability to respond to events of a critical incident. There is a newly projected radio system to replace the current one activated in 2019. The expected cost is about \$6000.00 per radio. The meeting also covered upcoming anti-terrorism meetings and training before the 2026 world cup which will affect the entire metro as well as surrounding states.

The Missouri Attorney Generals office has implemented a new add on for reporting that has been mandated by the new presidential administration. We will be working towards adding a reporting process that will identify if someone in the field we have contact with is here as an illegal immigrant and steps once that has been established. This is part of Missouri governor Mike Kehoe's newly signed executive order 25-05

The Platte County prosecutor's office is currently working one of our child abuse cases while deciding not to move forward on another at this time.

Chief Rivers attended training and certification as a counter terrorism office through the department of homeland security and the Missouri department of public safety. Attendance of the second session in the fall makes the Edgerton police department eligible for a grant of \$7500.00.

Emergency management- Siren did go off.
